## **GENERAL TERMS AND CONDITIONS**

- 1. The agreed daily charge includes full livery and exercising of a stallion to the owner's requirements.
- 2. Unless instructed otherwise, semen will be collected as often as a stallion's sperm reserves allow during a collection period. in practice, the most cost effective schedule is usually once every 48 hours or 3 to 4 collections per week. All ejaculates of which semen characteristics are within acceptable limits will be processed and frozen. Sub-standard ejaculates will be discarded and a charge will be made for the cost of collection and evaluation only. After processing, the post-thaw motility, concentration and longevity of each ejaculate will be evaluated. No doses of frozen semen will be recommended for use commercially unless the semen meets the minimum standards set by Westlands Stud. Although every effort will be made to freeze each stallion's sperm to the highest standard, no guarantee can be given for either the number of usable doses produced or for the conception rate that the semen will achieve when inseminated. At the end of the collection period, a full report on semen characteristics of each ejaculate will be prepared.
- 3. Insurance, it is the owners responsibility to insure the stallion whilst at Westlands Stud and to insure any stored frozen semen.
- 4. For stallions whose semen is intended for distribution in the UK and who may, therefore, be at the centre for several weeks, a deposit of £500 is required to cover initial period at the centre. If it is decided that the stallion's semen is unsuitable for freezing, the owner will be advised accordingly.
- 5. All charges will be invoiced to the stallion owner (or agent, if applicable) and payment is due on collection of the stallion from the centre. Any deposit paid will be allocated to the final account and any unused portion of the deposit will be refunded.
- 6. Routine veterinary, farriery and worming carried out at the centre will be charged at cost. Non-routine or emergency veterinary requirements will be referred to Stephen Brooks Equine Veterinary Practice who will charge the owner directly.
- 7. If the stallion is insured, the policy should cover at least death as a result of injury, illness, disease, theft or mysterious disappearance. Cover should include veterinary fees and liability. The insurers must be informed of the stallion's stay and Westlands Farm Stud must be noted on the policy whilst the stallion is resident at the centre.
- 8. Each stallion should arrive at the centre with the following items clearly marked: rugs as required, grooming kit, chifney covering bridle, headcollar and rope.
- 9. Every care will be taken whilst the stallion is at the centre, but no responsibility can be accepted for accident, theft or disease.
- 10. Walk in collections for shipment need to pay collection fee in advance. Credit and debit cards excepted.
- 11. The stud needs to be informed by telephone before 10am for chilled collections the same day.
